A Message From JFCS Leadership

Jewish Family & Children's Service (JFCS) continues to lead the way in providing effective, evidence-based social services to Maricopa County's most vulnerable populations. Because of your generosity, dedication and commitment to our mission, we are healing lives.

We have completed another productive fiscal year in 2018 serving our community and providing care for more than 42,000 children, teens and adults facing mental illness, family trauma, substance abuse and challenging financial circumstances, in addition to other serious behavioral, physical and social obstacles.

We have continued to forge a path focused on the "whole health" of those we serve. In February 2018, the JFCS Glendale Healthcare Center became the second JFCS facility to offer fully integrated healthcare services, including primary medical care and behavioral health services. Now, both the Michael R. Zent Healthcare Center in Maryvale and the Glendale Healthcare Center offer an integrated approach to patient care, combining to serve more than 12,783 patients in 2018. Our two clinics in Avondale and Mesa served more than 10,217 behavioral health patients last year, and we've furthered our plans to fully integrate both centers by 2020.

Other important milestones for 2018 include the expansion of our Hospital Chaplaincy services into the West Valley; a 31% increase in the number of women who received comprehensive domestic violence services from our Shelter Without Walls program; and a record number of diploma-earning graduates in the Real World Job Development program, which serves youth in or aging out of foster care.

We extend our deepest gratitude to our loyal donors and volunteers as well as our dedicated staff.

Glendale Clinic Becomes Integrated Healthcare Center

The JFCS Glendale Healthcare Center launched primary care services in February 2018, supported in part by Thunderbirds Charities. Becoming the second integrated medical and behavioral health center in JFCS' portfolio along with the Michael R. Zent Healthcare Center in Maryvale, both are providing a holistic approach to healthcare. The Center offers an integrated healthcare program where clients are treated by a collaborative team of therapists, clinicians, medical doctors, psychiatrists, nurse practitioners and other healthcare professionals. The coordinated care efforts of JFCS professionals serve every aspect of a patient's well-being in one convenient location.

Plans are in the works to relocate our Mesa clinic and open the JFCS East Valley Healthcare Center in late 2019, and to integrate our West Valley clinic in Avondale by 2020.



Mitzvah Hub Connects Volunteers to Organizations

In 2018, JFCS partnered with the Jewish Federation of Greater Phoenix to launch the Mitzvah Hub, an online, web-based platform where nonprofits and volunteers can easily access currently available volunteer opportunities in one centralized location. The Mitzvah Hub highlights the importance of supporting Jewish organizations both locally and around the world, irrespective of the religion of their beneficiaries. In addition to mitzvah projects, this resource is aimed at members of the community who are looking for ways to volunteer. It has already been utilized by b'nei mitzvah students, youth needing to complete community service requirements, as well as adult volunteers. Prevention Services Improves Student Learning

Approximately 4,300 students in the Scottsdale Unified School District received in-school prevention services via JFCS' Creating Peaceful Families program. New to the program this school year was goal setting and time management to target middle school students struggling academically, and more specifically, failing two or more classes.

Through teaching skills around goal setting, organization, following instructions, active listening, identifying appropriate resources and support systems, note taking, study skills, and self-evaluation, JFCS' new program assisted in preventing school failure and promoting academic success. 92% of students who participated in the program passed all of their classes. Moreover, JFCS received all "excellent" scores on customer satisfaction surveys returned from partnering schools.

Jewish Counseling Expands to Serve More Individuals

JFCS' Jewish Counseling program was established with the promise that Jewish individuals seeking services would not be denied treatment based on an inability to pay for these services. Though all of our programs are built from Jewish values, we offer some services catering directly to those of the Jewish community who would prefer more faith-focused counseling. The costs of these services are offset, in part, through insurance reimbursements and client fees, funding from the Jewish Federation of Greater Phoenix, and through the generous support

provided by a family foundation. This year, JFCS was able to expand the number of individuals who received counseling by 25%.

In addition to counseling, JFCS provides a number of other services specifically for the Jewish community, including Career Services, Older Adult Programs, Hospital Chaplaincy, Helping Hands – Emergency Financial Assistance, Holocaust Survivor Services, Aleinu community outreach and education, Jewish Crisis & Response Team and Chagim Holiday Programs.

JFCS Establishes Professional Leadership Program

With the help of a generous donor, Adam M. Brooks, CFP®, co-founder and managing partner of Scottsdale-based ABLE Financial Group, the JFCS Professional Leadership Program was established to engage more Arizona business professionals with JFCS. Modeled after leadership programs like Greater Phoenix Leadership and Scottsdale Leadership, a select group of professionals are recruited to join the program. Year one is spent learning about the history and mission of JFCS plus the wide array of services that JFCS offers the community. In year two of the program, the professionals leverage their knowledge to tackle a service project that benefits JFCS.

The inaugural cohort of diverse professionals selected for the JFCS Professional Leadership Program is currently completing the service project portion of the program. "On Feb. 8, my reality flipped upon itself. I was figuratively under water and struggling to breathe. The loss of my dream job as a sous chef due to injuries sustained from a car accident put me in a seven month "funk." During that time, there were moments of contemplating suicide...my existence seemed bleak. I reluctantly reached out for help up, not a handout, and was connected with JFCS' Glendale Healthcare Center.

I faced extreme anxiety and panic attacks following my diagnosed Traumatic Brain Injury, which almost prevented me from showing up to my first scheduled appointment. I am forever grateful that I did, however. Everyone I came into contact with at JFCS made me feel acknowledged and valued as a human being. Knowing that this team of professionals is working in unison makes me confident in my healthcare decision. Thank you for all the extra effort and care I have received, you truly saved my life."

It's my greatest hope that through a lot of hard work and determination, my parents will overcome this challenge. I do not want to see my family broken apart or to have us removed from our home. My greatest fear is being placed in the foster care system with people I don't know. Thank you to JFCS and everyone who reached out to get us the help that we clearly needed!"






