A MESSAGE FROM JFCS LEADERSHIP

Jewish Family & Children's Service (JFCS) achieved remarkable growth during fiscal year 2016 as our agency touched the lives of a record 47,739 children, teens and adults facing mental illness, family trauma, substance abuse, challenging financial circumstances in addition to other serious behavioral, physical and social obstacles.

The growth in the number of individuals our agency served represents a 15 percent increase over last fiscal year. Most of the growth occurred under our Jewish Community Services umbrella of programs, which supports Jews of all ages and from all walks of life. Our Older Adult Services, Jewish Career Services, Helping Hands emergency assistance, Chagim holiday program and Hospital Chaplaincy program represent just a few of the many services and programs we provide as part of Jewish Community Services. We increased the number of Jewish individuals served by 59 percent, jumping from nearly 5,939 last year to almost 10,046 this year.

We also remain steadfast in our resolve to serve children and teens who are facing unimaginable circumstances often without any healthy adult role model in their lives. The foster care crisis in Arizona remains one of our top areas of focus as we serve more than 2/3 of the foster youth referred to the Maricopa County Regional Behavioral Health Authority. In fiscal year 2016, there were slightly more than 18,000 children in state care, representing a small decrease from 2015.

Our behavioral health services combined with programs like Real World Job Development, which equips foster teens with job skills and internships, and Transition Age Youth, which provides independent living skills, help the hundreds of young adults who age out of state care each and every year.

In everything we do, our goal is to set people up for success. That's why we believe in a whole health model of care. More than 70 percent of our behavioral health patients suffer from one or more chronic physical health conditions, and their life expectancy is 25 years less than the general population. Through our innovative Michael R. Zent Healthcare Center, we are offering fully integrated primary medical and behavioral healthcare, and we are working toward replicating this at all our clinics.

We couldn't achieve success without the hundreds of passionate staff members who have made it their life's mission to serve those in need, or our generous donors and volunteers who give back to our community financially or with their time. We owe a tremendous debt of gratitude to those who have joined our efforts to do whatever it takes to heal the lives of those in need.

Volunteer program launched in 2016



Recognizing that volunteers are a valuable resource to not only our agency but also to our entire community, JFCS launched its volunteer program beginning with the hiring of Jody Goldman, a part-time volunteer coordinator in the Spring of 2016. In the first six months, more than 50 volunteers were recruited, trained and placed in several volunteer roles, including:

- Classroom tutors for Real World Job Development
- Activity leaders and gift shop assistants at the Center for Senior Enrichment
- Mentors for the Shelter Without Walls program
- Donors and coordinators for the Just Three Things food pantry
- Ambassadors to represent JFCS at various community events
- Monitors for the children's play area at the Michael R. Zent Healthcare Center
- Special event volunteers to assist with our annual events, "It's a Wrap" and the holiday dinner for foster children.

Largest group of foster youth graduates



The Transition Age Youth program at JFCS saw the largest class of students graduate high school since the program's inception, helping 42 foster teens and young adults on the path to independence. In total, 563 young adults participated in the program during fiscal year 2016, receiving help with career planning, daily living skills, housing and money management, work-life skills, communication and societal relationships.

In addition, 156 at-risk youth ages 14 to 24 built their work readiness and academic skills to prepare themselves for a successful transition into adulthood through the Real World Job Development program. Through one-on-one coaching and peer group sessions, foster youth who are phasing out of the system obtain independent living skills and positive community supports. The program scored an 87.5% in overall performance, which included metrics such as literacy/numeracy; attainment of GED, high school diploma or another post-secondary credential; and youth who obtained employment.

JFCS exceeds behavioral health training requirements

JFCS received a 98% compliance rating from the Arizona Department of Health Services for timely completion of all of the Division of Behavioral Health Services (DBHS) and Regional Behavioral Health Authority (RBHA) training requirements for staff for the reporting period ending in December 2016. This includes initial new hire 90-day, ongoing and annual training requirements. For an agency of 650 employees and close to 200 new staff members in the past year, this achievement demonstrates that training requirements and compliance are a top priority for JFCS staff. The RBHA threshold is 85%, so a rating of 98% ranks among the best in the state.

Michael R. Zent Healthcare Center is dedicated, serves as model

JFCS celebrated the opening of a new integrated medical and behavioral health center in the underserved Maryvale neighborhood of Phoenix. The Michael R. Zent Healthcare Center, named in honor of the highly regarded JFCS President & CEO who passed away in early 2016, serves a growing number of Maryvale children and families with complex physical, mental health and substance abuse issues. Seventy percent of these patients also have at least one ongoing medical condition.

The new center was designed specifically to provide both medical and behavioral health services in an environment where clinical and support staff work together, sharing treatment information electronically to determine the best course of action for each person's health. JFCS' goal is to use this clinic as a model and replicate the integrated care approach at the three other JFCS healthcare clinics in Maricopa County.



Shelter Without Walls adds domestic violence support staff



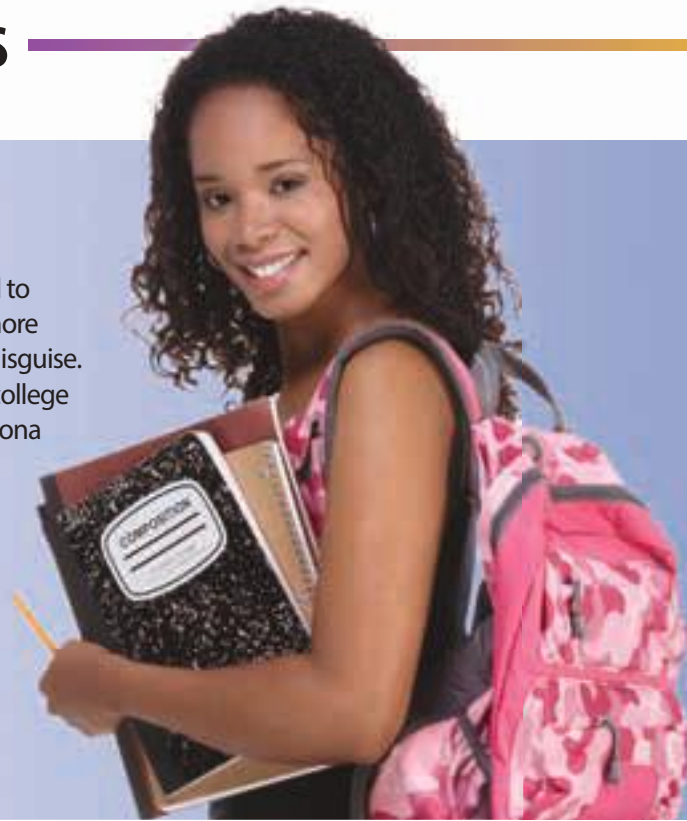
Shelter Without Walls added a new domestic violence advocate and trauma therapist to its support staff, enabling the agency to address the unmet needs of survivors of domestic violence and their children who are residing outside of a shelter setting and are struggling to attain and/or maintain safety and independence whether or not they are still living with their abuser. JFCS domestic violence advocates work closely for as long as it takes with victims to ensure their safety and ability to provide for themselves and their children while maintaining their independence. Shelter Without Walls has plans to expand to six full-time employees by 2020 and the T.W. Lewis Foundation generously offered a four-year challenge grant in the amount of \$200,000 if matched 3:1 over five years.

TRANSITION AGE YOUTH

After bouncing around from one group home to the next, I was encouraged to take part in the Transition Age Youth program for foster teens in my sophomore year of high school. My Transition Facilitator at JFCS was a huge blessing in disguise. She encouraged me to pursue my college dreams and worked with me on college and scholarship applications. I recently found out that I was accepted to Arizona State University, and I received a \$24,222 scholarship for 2016-2017 from the Barack Obama Scholars Program, as well as a \$2,000 stipend per year for all four years of college. I also received a Pell Grant. I'm so grateful for my facilitator's help. She showed me that college is really within my reach!

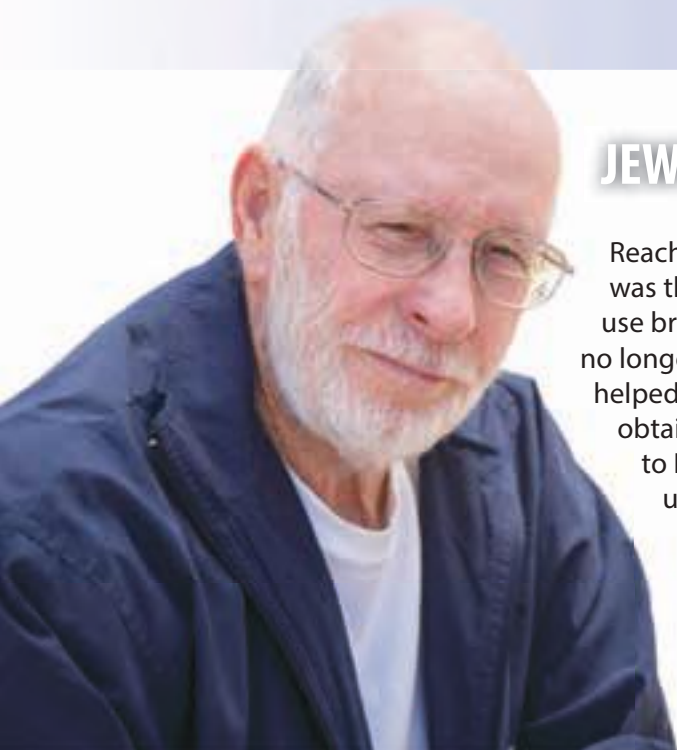

JEWISH COMMUNITY SERVICES

Reaching out to Jewish Community Services for assistance with housing was the best decision I ever made. I suffer from Muscular Dystrophy and use braces and a cane to get around. I'm on a fixed income and I was no longer able to use the stairs to get to my apartment. My caseworker helped me apply to Kivel HUD housing and contacted a lawyer to help obtain permission to be released from my lease. Not only was I accepted to Kivel Manor and now have a handicapped-accessible apartment unit, but my rent is now substantially more affordable. JFCS' Helping Hands program also paid my first month of rent, which allowed me to budget for my move. I've made new friends in my community, and I'm able to use Kivel transportation to maintain my independence.

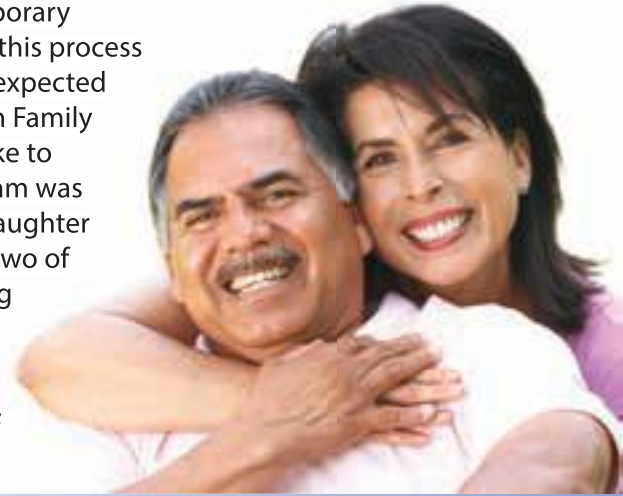

HOMEBASED, CHILD WELFARE SERVICES, FAMILY REUNIFICATION

Last fall, the Department of Child Safety came into our lives giving us temporary custody of our grandson. We dealt with a number of organizations during this process and felt as if we weren't always treated with respect. Going through an unexpected situation like ours can be humiliating and embarrassing. The staff at Jewish Family & Children's Service, however, was absolutely outstanding and always spoke to us with the utmost respect and concern for our family's well-being. The team was caring, positive and really knew how to listen. We're happy to report our daughter has finally been given unsupervised visitation with our grandson and the two of them are now living with us. The communication, budgeting and parenting training that our daughter received is helping her become a successful single parent.

SHELTER WITHOUT WALLS



I came to Shelter Without Walls four years ago because I was in an abusive relationship. Shelter Without Walls helped me break free from the cycle of abuse in my life and supported me in many ways. I had been in an abusive marriage for 17 years and in my late 40s, the abuse became unbearable. I was intimidated to leave because I had no real job skills and three children, ages 8, 10 and 16. Shelter Without Walls helped build my self-esteem and showed me I had the strength to do anything I put my mind to. They were there through my divorce and court proceedings. They were there to help me get my GED and first job. They were there when I received my associate's degree in Criminal Justice, and I know they'll be there when I graduate from NAU with my bachelor's degree so I can become a probation officer and help people get their lives back on track. Shelter Without Walls has been there every step of the way for not only me, but also my three children, and for that I am eternally grateful.

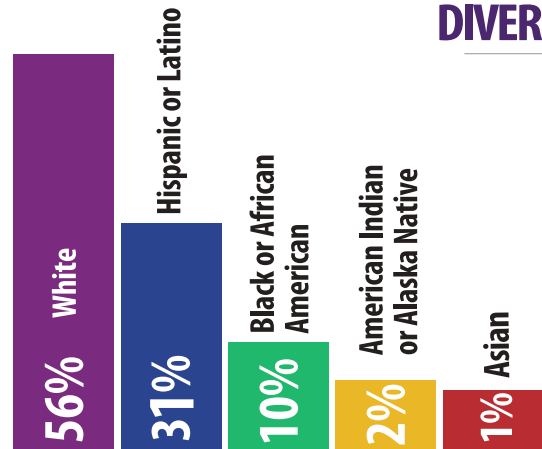

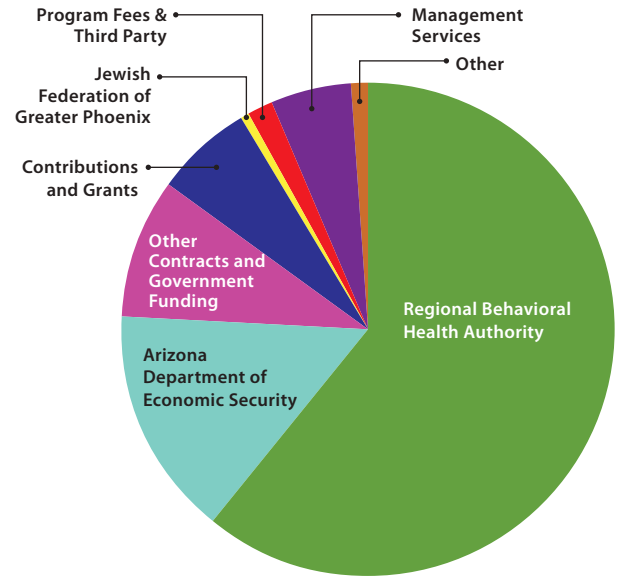

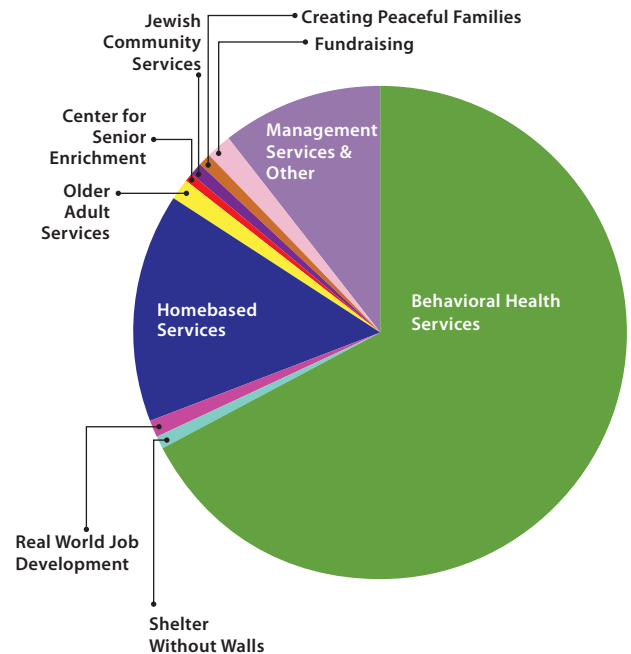
