#### WHAT IS IT?

The Arizona Charitable Tax Credit is a tax credit for people who have made donations during the tax year to a Qualifying Charitable Organization such as **Jewish Family & Children's Service (JFCS)**.

#### WHAT DOES THIS MEAN FOR YOU?

When you donate to JFCS, you will receive a dollar-for-dollar tax credit on your Arizona state income tax return. This means that **you can SUBTRACT the amount of your donation from the amount of taxes that you owe**. It's an easy way to help children and adults in need overcome mental health and life challenges.

#### CAN I RECEIVE MULTIPLE TAX CREDITS?

**Yes.** You can participate in all of the AZ tax credit programs, and **receive a separate tax credit for each donation you make.**

#### HOW MUCH WILL I RECEIVE?

If you are a **single taxpayer**, you can **receive a charitable tax credit up to \$400**. **Couples filing jointly can receive up to \$800** credit on their Arizona State income tax return. It is a direct dollar-for-dollar credit back to you.

#### HOW DOES IT WORK?

Make your donation to JFCS by mail, or online at **JFCSAZ.org/CREDIT**. List JFCS as your charitable organization along with your donation amount on the **AZ Tax Form 321**. Every Arizona taxpayer who donates to JFCS qualifies for the Arizona Charitable Tax Credit. **You do not need to itemize deductions to claim the tax credit.**
